Training Corner

ODPANN 24-110 ODP Deaf, Hard of Hearing, Deafblind Required Training

Pennsylvania's ODP has announced a new training requirement regarding the Deaf, Hard of Hearing and Deafblind communities. It's been assigned to direct care positions, as well as some other roles. You will notice it in your Relias assignment list and it's due January 15, 2025. This training will be completed on the myODP.org website.

When you start the course in Relias, you will see a set of instructions about how to log in and access the training. Please refer to the instructions for the list of required sections. When all of the required sections have been completed, you will be issued a certificate from myODP.

Very important! Please forward the certificate from myODP to sftraining@shadowfax.org, not the completion certificate from Relias. A copy of this certificate will remain in your training file.

American Sign Language

A free online ASL course is available to any team member who is interested. It is an internet-based selfstudy that is suitable for community education or general learning. Students will learn basic vocabulary, grammar, history, fingerspelling, numbers, terminology, and Deaf culture. It is offered through lifeprint.com, and is maintained by Dr. William Vicars, ED.D. You can work through the lessons in order and will have access to many resources. Search "ASL 1" in the Relias Course Library or click on the link: <u>ASL</u>

Did you know? These classes become available in your Relias assignment list 180 days before your due date! This allows you to plan ahead, and not miss due dates. This includes: Other than Oral Medications, Red Cross FA/CPR/AED Skills Session, and Diabetes Education. All trainings are subject to change. Check Relias for the most up-to-date schedule and location when enrolling in a class.

Professional Credentials Earned through the NADSP E-Badge Academy

Attention DSPs & Direct Supervisors of DSPs:

If you have been employed at Shadowfax for at least 6 months, and you're interested in pursuing a professional certification, here are some quick facts about the E-Badge Academy Program!

- * You can earn badges toward certification at your own pace.
 - * Example: DSP-I requires 15 total badges.
- * Each badge only takes an average of 15 minutes to prepare and submit.
- * Many Relias annual trainings count towards certification.
- * After earning a certification within a year of enrollment, receive an hourly pay increase!
- * New groups are enrolled quarterly.

Safety Corner



Tis the season for Holiday Safety.

Tree Safety:

- 1. Turn off Christmas tree lights.

Med Task Force



Remember to slow down and take your time with medication administration. Medication errors can easily occur when rushing and distracted. Start preparing and administering medications at the beginning of the administration window. Limit distractions in the environment as much as possible. Prepare medications in a clean uncluttered environment. Keep medication storage areas clean and organized. Pay close attention to details and if you are unsure of anything stop and seek clarification.
